In the event of a lapse of coverage, expiration, or failure to procure any insurance required herein, P Park reserves the right to prohibit the Customer’s access / entrance on to the Site, until such coverage has been re-established and / or secured with sufficient evidence of the same being provided to P Park.

Indemnification / Hold Harmless:

To the fullest extent permitted by law, the Customer shall defend, indemnify, and hold harmless P Park NJ, LLC as well as their officers, directors, partners, agents, affiliates, representatives, and employees from and against any and all claims, costs, suits, expenses, losses, damages, liabilities, and professional fees, including reasonable attorney’s fees, resulting from, arising out of, or in any way connected with the acts and / or omissions of the Customer or the Customer’s officers, directors, partners, employees, agents, sub-contractors, sub-consultants, or independent contractors, including claims by any employees, or the performance of the Customer’s activities while entering, exiting or on the Site.

Waiver of Subrogation:

The Customer, on behalf of itself and its insurance companies, waives all rights against P Park for any loss, damage, or injury whatsoever.

Successors and Assigns:

The Customer binds itself, its partners, successors, executors, administrators, representatives, and assigns to all covenants herein. The Customer shall not assign or transfer his interest in the quotation or other agreement with P Park without the written consent of P Park.

Incorporation of These Provisions:

It is hereby agreed by P Park and the Customer that the foregoing insurance and indemnification provisions are a part of each and every contract and / or agreement, by and between P Park and the Customer, and that the obligations of the Customer to P Park shall survive the completion of the activities by the Customer on the Site.

Other Conditions:

The Customer acknowledges and agrees that the failure of P Park to specifically enforce any of the above-referenced provisions shall not waive the responsibility of the Customer to comply with all insurance and indemnification conditions and requirements set forth herein.
